If the parties cannot agree on appointment of the Arbitrator within a period of one month from the notification by one party to the other of existence of such dispute, then the

Arbitrator shall be nominated by the secretary, Department of Legal Affairs, Ministry of Law & Justice, Govt. of India. The provision of the Arbitrator and Conciliation Act, 1996 will be applicable and the award made thereunder shall be final and binding upon the parties hereto, subject to legal remedies available under the law. Such differences shall be deemed to be a submission to arbitrator under the Indian Arbitrator and Conciliation Act, 1996 or of any modification or reenactments thereof.

Have Reached the following understanding: -

ARTICLE 1

OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MoU) is to cooperate in educational, research and extension activities in areas of mutual interest.

ARTICLE 2

SCOPE OF COOPERATION

The Parties agree to implement cooperation programmes including but not limited to:

EXECUTING AGENCIES**

To implement this MoU: -

2. DC appoints the Coordinator, IQAC, DC (hereinafter referred to as DC Rep).

**ARTICLE 5
FINANCIAL ARRANGEMENT**

3. Any cooperation under this MoU is subject to the availability of funding sources and approval by relevant authorities.
4. Any specific project of joint interest will be detailed in a separate agreement, including financial and programme specific arrangements.

**ARTICLE 6
INTELLECTUAL PROPERTY RIGHTS**

1. Each Party shall protect, within its capacity and territory, intellectual property rights of the other Party in accordance with the laws and regulations in force in the state of Assam and the country of India.
2. In case of specific arrangement, programmes, activities or projects that may result in intellectual property, the Parties shall conclude separate arrangement in accordance with the prevalent laws and regulations in the state of Assam and the country of India.

ARTICLE 7
CONFIDENTIALITY

In the event that either Party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MoU, the disclosing Party shall have prior written consent of the other Party.

ARTICLE 8
LIMITATION OF PERSONAL ACTIVITIES

The Parties shall ensure that their personnel engaged in the activities under this MoU shall engage only in activities under the framework of this MoU with respect to laws and regulations in the state of Assam and the country of India.

ARTICLE 9
SETTLEMENT OF DISPUTES

Any dispute concerning the interpretation and/or application of this MoU shall be settled amicably through consultation or negotiation between Parties.

ARTICLE 10
AMENDMENT

1. This MoU may be amended or revised at any time by mutual written consent of the Parties, and such amendment shall form an integral part of this MoU.
2. Such amendment or revision shall come into force on the date as may be determined by the Parties.

ARTICLE 11
ENTRY INTO FORCE, DURATION AND TERMINATION

1. This MoU shall enter into force on the date of signing.


2. This MoU shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by mutual consent of the Parties.

 - c. Endeavor to encourage students to spend periods of time in the host campus.
 - d. Adarsha Samaj Kalyan Samittee will conduct skilled courses (Medical Laboratory Technician and 02 others) as mutually agreed in writing between the parties prior to commencement of this activity.
 - e. Adarsha Samaj Kalyan Samittee will conduct skill project, as mutually agreed in writing between the parties prior to commencement of this activity.
2. College will provide electricity and the electricity bill be paid by the College itself.
3. College will provide facilities like drinking water, wash room, canteen etc. for trainees and staff.

4. Adarsha Samaj Kalyan Samittee will give 100% preference to Dhing College students (pass out and final year). However, if any seats remain vacant will be filled up by outsiders.
5. College Staff, Students' Union or any other person will not be allowed to communicate or create any disturbance on allotted place. Only one College staff will communicate with Adarsha Samaj Kalyan Samittee directly.
6. Adarsha Samaj Kalyan Samittee will provide all required laboratory equipment and the College shall provide necessary infrastructure.
7. The College will allot time for taking classes from 2.00 p.m. onwards.
8. As discussed with the College authority, Adarsha Samaj Kalyan Samittee will be able to support and arrange extra-curricular activities within the stipulated time.
9. The trainees will not be allowed to access College Library, Laboratory, College Wi-Fi System, Students' Union Room etc.

This agreement will take effect from the date of its signing and shall be valid for two years period from that date unless sooner terminated, revoked or modified by mutual written agreement between the parties. The period may also be extended by mutual agreement between the parties.

Either party may terminate the agreement during the term by the provision of three months written notice to the other parties.

5. All the parties have agreed that they will extend every form of co-operation to each other.





7. **However, the agreement can be extended to organize more such types of programmes in future.** All the parties will be responsible for organizing and managing the online training program as per the provisions mentioned above.

9. The agreement shall be made in two identical copies. All the versions are equally valid. Each of the parties of the agreement shall receive one copy of the agreement.

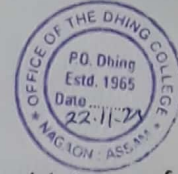
